

Official DreamScape 2011 Raffle Rules and Regulations

Entry conditions are posted on the Internet at www.okcbeautiful.com

This raffle starts 1/01/2011 and ends 5/31/2011. The raffle is sponsored by OKC Beautiful, a 501(c) (3) nonprofit agency, 3535 North Classen Boulevard, Oklahoma City, OK 73118.

HOW TO ENTER: Visit www.okcbeautiful.com and click on the DreamScape Raffle logo to download a ticket order form, or make purchase online. Print and complete. Mail or fax the order form to DreamScape Raffle, OKC Beautiful, 3535 North Classen Boulevard, Oklahoma City, 73118, Fax 405-525-8826.

Payment for raffle tickets may also be presented to members of OKC Beautiful's Board of Directors, or at the offices of OKC Beautiful, 3535 North Classen Boulevard, Oklahoma City, OK 73118. Tickets may also be purchased at the vendor partner retail outlets. Checks should be made payable to OKC Beautiful. The price for one ticket is \$25 or five tickets for \$100. Entries must be postmarked by, May 31, 2011, to be eligible to win.

Odds of winning are dependent on the number of tickets sold out of a possible 1,500 total tickets. The winning ticket holder will receive their choice of a professional front or back yard makeover, up to a value of \$10,000, to be implemented during the summer of 2011. The winner will be called and notified by mail. They need not be present at the drawing to win on Thursday, June 2, 2011 at 12:00 P.M. at Memorial Park. If the winner cannot be reached at the phone number on the ticket receipt and/or the mail notification is returned as undeliverable for any reason by July 1, 2011, a disqualification will result, and an alternate winner will be drawn.

The winner is required to execute, sign, and return within 14 days of notification, signed Affidavit of Eligibility and release of liability forms. If the winner does not execute and return the Affidavit of Eligibility and release of liability within the 14 days provided, the winner will be deemed ineligible and an alternate winner will be drawn.

The purchase of a DreamScape raffle ticket is not tax-deductible. All ticket sales from the DreamScape 2011 Raffle will be used to fund the OKC Beautiful MiniScape program.

Only real property located in the City of Oklahoma City qualifies for the DreamScape makeover and the winning ticket holder must be the record owner of such property.

All employees of OKC Beautiful and the vendor partners and their immediate families are ineligible to participate.

As a ticket holder, you must understand and agree to the foregoing and abide by the following rules for the DreamScape 2011 Raffle:

- 1 - The winner must meet with the DreamScape Landscape Architect by July 1, 2011.
- 2 - Winner must sign a contract agreeing to the landscape plan designed for their Oklahoma City property and to the work that would be performed by the pre-designated DreamScape 2011 Raffle vendor partners by July 15, 2011 or a new winner will be selected and alternative dates established by OKC Beautiful.
- 3 - Winners are subject to any and all federal, state and local income taxes based on fair market value of the prize. Winners will be mailed an IRS form 1099-MISC for the stated value.
- 4 - There is no cash payout for the value of the \$10,000 landscape makeover, and there are no substitutions for prizes. The prize may be transferred in whole (but not in part) to the Oklahoma City property owner with the approval of OKC Beautiful. The person to whom the prize is transferred is bound by all rules and regulations of the promotion, as if he/she was an applicant prize winner. A signed declaration agreeing to such rules and regulations must be received by OKC Beautiful before any transfer can become effective.
- 5 - OKC Beautiful and the DreamScape partners will provide a limited warranty on the work, plant materials, and garden features for up to one year with proper maintenance of the new landscape by the property owner.
- 6 - Except where prohibited by law, prize acceptance constitutes permission to use the winner's name, biographical information and/or likeness for purposes of advertising and promotion in all media without limitation or further compensation. Front yard is defined for these purposes as the portion of private property at the winning residence or business that is visible from the street.
